

Dear Visa Applicant(s),

Bales Worldwide have recommended CIBT to assist you in applying for your Iranian tourist visa(s). Please ensure you read the following information thoroughly and submit this form when returning your application.

DEADLINE: Documents must be received by CIBT no earlier than 3 months prior to entry into Iran but no later than 35 calendar days prior to the date you require your passport(s) back.

- Late submission fees of £5.88 per person will apply if you allow fewer than 35 days for processing (this does not guarantee your application will be processed quicker than 35 days).
- Please note applications cannot be withdrawn from the Iran Embassy once lodged by CIBT.

REQUIREMENTS FOR BRITISH CITIZENS ONLY

Please send the following documents (per applicant):

- British Citizen Passport. It must have 6 months validity beyond the completion of your trip. It must be in **tidy** condition, have at least two blank pages and contain no Israeli stamps.
- One application form, signed and dated. Please complete in capitals in black ink only.
- One passport-type photograph. It must be in colour taken against a plain white background. Women should observe the Islamic dress code by wearing a scarf to cover their hair. Please do not staple photos onto the form.
- Copy of official tourist authorisation (or telex) from Iran (provided to you by Bales Worldwide with this visa pack).
- Completed Client Form for CIBT (overleaf) and payment for visa application (see note below).
